

“VINTEC CLUB” PROMOTION

TERMS AND CONDITIONS

1. Information on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Entry is only open to Australian residents aged 18 years or over that are current members of the Vintec Club.
3. Employees (and their immediate families) of the Promoter, and agencies associated with this promotion are ineligible to enter.
